The winner will be selected by random drawing from all eligible entries received during the Contest Period. Each eligible submission will be assigned a number; the winning number will be drawn using



Random.org after the submission period closes on May 12, 2026. The drawing will take place on or before Friday, May 16, 2026. Sponsor's decisions are final and binding in all respects. Odds of winning depend on the number of eligible entries received.

One (1) winner will receive one (1) Amazon.com Gift Card in the amount of \$100 USD (Approximate Retail Value: \$100).
